- 3. Registration is open on the Members' Mobile Apps only. Please register via Members' Mobile App from 12:00 nn, 13 August to 6:00 pm, 22 August.
- 4. The event fee for each member is HK\$300. Each Member may reserve up to 2 pax, reservation and seating will be allotted on a first-come, first-served basis. The Club reserves the right to run and utilise a shared table, participants will be arranged to sit with other parties, subject to availability.
- 5. Age limit of enrolled member: 18 years old or above.
- 6. Member successfully enrolled in the event will receive a confirmation email with the event details 7 days prior to the event date. Once the enrolment is confirmed, all charges will be collected after the event day via the relevant membership account and are non-refundable. The exclusive privileges are reserved for Members who have both reserved and attended the event, and are non-transferable.
- 7. If the event is full, the enrolment will be put on a waiting list on a first-come, first-served basis according to the time of enrolment.
- 8. The Hong Kong Jockey Club (The "Club") may use images and videos of you and your guests taken during the event for promotional and/or record purposes.
