Authority To Act
and Undertaking of Ownership Obligations

- 1. I/We hereby inform you that I/we have authorised Mr. (Trainer) of The Hong Kong Jockey Club (the "Club") until further notice to enter all or any of the horse(s) registered with The Hong Kong Jockey Club in my/our name(s) in any race or races to be held by the Club, to withdraw any such horse, to declare such horse to start, to engage jockeys as necessary and to sign any forms that may be required for such purposes. My/Our appointed trainer is authorised, in accordance with Stewards' Instructions 29, to ensure that any Jockey engaged to ride my/our horse understands that the horse is to be ridden in such a manner as to obtain the best possible placing.
2. I/We hereby authorise the Club to debit my/our account with all registration fees, entrance fees, riding fees and accident fees payable in respect of each horse entered in each race, as soon as such fees shall become payable.
3. I/We accept:—
a. Full personal responsibility for the horse(s) shown below upon the terms of The Hong Kong Jockey Club Ownership Bye-Laws and Horse Ballot Bye-Laws in force.
b. My/Our responsibility as an owner under the Rules of Racing and the Instructions by the Stewards of the Jockey Club.
c. Applicable to partnerships only, that each of us shall be jointly and severally liable for:
(i) any entrance money, stake, forfeit or any other liability in respect of the horse(s);
(ii) any act and/or omission of each other partner; and/or
(iii) any breach or non-observance by each other partner of the Club's Bye-Laws and/or Rules of Racing; and notwithstanding the absence of prior knowledge or acquiescence.
d. I/We hereby declare that I/we will personally manage the horse(s) shown below and that the horse(s) is/are absolutely owned by the Registered Owner(s) stated below as required under Rule 40(1) of the Rules of Racing.
e. I/We hereby declare that I/we will not sell, lease, lend or in any other way deal with or dispose of my/our horse(s) either wholly or in part, without the permission in writing of the Stewards of the Jockey Club.
4. I/We hereby represent to and agree with the Stewards that should it be established to the satisfaction of the Stewards of the Jockey Club that I/we and/or, applicable to syndicates only, any member of the Syndicate of which I/we the undersigned are members subsequently dispose or deal in the horse(s) (whether by disposal of my/our entire interest in the horse(s) or a part interest in the horse(s)) then I/we and any other parties involved will not only in breach of the Ownership Bye-Laws but will also be deemed to be guilty of a corrupt or fraudulent practice contrary to Rule 150 of the Rules of Racing whereby, firstly I/we shall be subject to such penalties as may be applicable under the Rules of Racing and, secondly, I/we will be guilty of conduct making me/us liable to disciplinary proceedings pursuant to the Articles of Association of the Club.
5. I/We acknowledge that penalties for corrupt or fraudulent practices include fines, disqualifications from and warning off all premises owned or operated by the Club for such period (including sine die) as the Stewards may determine and/or expulsion from/or suspension of membership of The Hong Kong Jockey Club. I/We acknowledge that any suspension or disqualification imposed by the Club may be reciprocated by any other Turf or Racing Authority without further enquiry.
6. I/We also acknowledge and agree that I/we shall be solely responsible for all risks in connection with the horse(s) including its participation in any training or racing activities in Hong Kong or overseas, and for effecting all appropriate insurance coverage in respect of such risks. It is specifically acknowledged and agreed that the Club shall not in any way be liable for any loss of or injury to any horse howsoever caused (including any loss or injury resulting from default or negligence of the Club, its agents or contractors) at any time, including without limitation, any time prior to import, during transit, after the horse's arrival in Hong Kong, in the stable, training, racing or other facilities of the Club or other entities in Hong Kong or elsewhere, or in transit between such facilities.
7. I/We agree to abide by the Rules and decisions of the Stewards of the Jockey Club and of any sub-committees thereof.
8. I/We acknowledge that this Authority To Act does not absolve me/us from my/our responsibilities as an Owner under the Rules of Racing.
