- This application is subject to the horse passing a pre-export veterinary examination. The pre-export veterinary examination will be carried out solely to determine the horse's suitability for export from Hong Kong and is not equivalent to a full pre-purchase veterinary examination. I/We accept that the Veterinary Surgeon's findings are for my/our information only and should not be treated as conclusive.
- I/We am/are responsible for all livery charges incurred until the time of export in addition to the full export charges. I/We will settle all charges either through my/our Club account or by cheque/bank draft at least one week prior to shipment.
- The horse is exported under my/our ownership and solely at my/our own risk and responsibility. The horse **is NOT to be used for re-sale / breeding / racing /commercial purposes unless with prior written approval from the Club / original owner.**
- I/We **shall NOT transfer or lease the horse ownership without prior written approval from the Club.**
- After export, I/we will ensure that adequate veterinary treatment is given whenever necessary and that acceptable stable management practices are maintained at all times whilst the horse remains under my/our ownership.
