- (c) To the best of my knowledge and belief, all information provided in this Form relating to the Horse, its purchase or transfer, ownership structure, any contingency or arrangement and any agent involved, are complete, true and accurate.
- (d) I shall promptly notify the Club of any change to the ownership interests in the Horse notified to me and provide such further information or documents as the Club may reasonably require in connection with the registration of the Horse.
- (e) I acknowledge that the Club may exercise its powers under Rule 40 of the Rules of Racing, including requiring further information in relation to the ownership of the Horse or refusing registration its registration without providing any reasons.
- (f) I/we, under the delegated authority of all syndicate members, consent to the Club, its affiliates and their authorised service providers, business partners, licensees and other authorised parties (together, the “Authorised Parties”) using any materials, information and intellectual property rights relating to the Horse, including its name, image, likeness, race footage, photographs, racing records, racing colours, silks, logos and other identifying materials (“Horse Materials”) as follows:-
 - (i) The Authorised Parties may use, reproduce, publish, display, adapt, license, sublicense or otherwise make available the Horse Materials in Hong Kong, the Chinese Mainland and elsewhere for promotion, marketing, fan engagement, education, commemorative activities, merchandising, digital content, games and other activities connected with racing and the related businesses of the Club and its subsidiaries. This includes use in publications, exhibitions, websites, social media, mobile applications, merchandise, digital content, games and other products, content or experiences, whether created, published or made available before or after the date of this consent. The Horse Materials may be used on their own or together with other materials.
 - (ii) This consent is ongoing and royalty-free. No compensation, fee, royalty, revenue share or other payment will be payable in connection with the uses covered by this consent.
- (g) I have read and understand the Club’s Privacy Policy Statement at https://www.hkjc.com/home/english/corporate/corp_privacy.aspx. Where I provide personal data relating to any syndicate member or third party in connection with this form, I confirm that I have obtained the necessary consent for the collection, use, disclosure and transfer of such personal data for the purposes of this declaration and the other purposes set out in the Club’s Privacy Policy Statement.
